

ANIMAL CONTROL AND ANIMAL SHELTER SERVICES

CONTRACT EXTENSION

TOWN OF HEBRON, INDIANA

THIS AGREEMENT, made by and between the Board of Commissioners of Porter County, Indiana and the Town Council of the Town of Hebron, of Porter County, Indiana;

WHEREAS, the Board of Commissioners of Porter County, Indiana and the Town Council of the Town of Hebron, Indiana entered into an Animal Control and Animal Shelter Services Contract effective August 1, 2021 through July 31, 2026 (the "Prior Contract"), under which the Town of Hebron paid an annual rate of \$6,393.00 for the contract year of August 1 through July 31; and

WHEREAS, the parties desire to extend the Prior Contract for a period of five (5) months to ensure uninterrupted continuation of animal control and shelter services while the parties complete negotiation and execution of a new long-term interlocal agreement; and

WHEREAS, the parties desire that the extension period be governed by the same terms and conditions as the Prior Contract, including the same rate of compensation, prorated on a monthly basis for the duration of the extension period;

BE IT AND IT IS HEREBY AGREED by the Board of Commissioners of Porter County, Indiana and the Town Council of the Town of Hebron, Indiana:

I. EXTENSION OF CONTRACT TERM

- The term of the Prior Contract is hereby extended from August 1, 2026 through December 31, 2026.
- All terms and conditions of the Prior Contract, including all service obligations of the parties, shall remain in full force and effect during the extension period.

II. PAYMENT

In consideration of the above-described services, the annual rate of \$6,393.00 paid by the Town of Hebron under the Prior Contract is equivalent to a monthly rate of \$532.75. For the five (5) month extension period of August 1, 2026 through December 31, 2026, the Town of Hebron shall appropriate and pay to Porter County, Indiana the sum of:

- **Two Thousand Six Hundred Sixty-Three and 75/100 Dollars (\$2,663.75)**, to be paid by October 1, 2026.

- Payment shall be made payable to the Porter County Treasurer for deposit into the Porter County Animal Control Fund and the Porter County Animal Shelter Fund.

III. RELATIONSHIP TO PRIOR CONTRACT AND NEW AGREEMENT

- This Extension Agreement does not modify any term of the Prior Contract except as to the contract term set forth in Section I above and the prorated payment set forth in Section II above.
- Execution of this Extension Agreement does not obligate either party to execute any subsequent long-term interlocal agreement for animal shelter or animal control services.
