Hebron Park Board Minutes August 10, 2023

The Hebron Park Board held its regularly scheduled meeting on August 10, 2023 at the Stagecoach Inn.

The meeting was called to order by President Linda at 7:17 pm.

Members in attendance: Linda Brebner, Don Ensign, Jacqueline Lipski, Dorothy Michalak, Cindy Ollom, John Spinks, Frank Stalbaum, and Jenny Wallace. Danielle Roeske Hogg also attended.

Minutes of the July 13, 2023 meeting were reviewed. Jenny made a motion to approve the minutes; Don seconded, and the motion passed.

Treasurer's Report: Account balances: \$3166.98 in maintenance and supplies, \$2750.07 in programs, \$3908.00 in equipment, and \$12,910.25 in the gift fund. Don made a motion to approve the June treasurer's report; Dorothy seconded, and the motion passed. Don made a motion to approve the invoices; Dorothy seconded, and it passed.

Danielle Hogg, as a member of the Chamber of Commerce, visited the businesses in town to gather feedback on how the Chamber can help and what can be improved, among other questions. Her discovery was few businesses were happy. Finding Frosty seemed to be the high point. The Chamber needs more members to be involved and to be active in the Chamber.

Old Business: The Fall festival will be October 7th at Alyea Park. **Projects completed:** the basketball court at Alyea, the park signs painted, the gazebo at Cohen, and the shelter on the trail stained.

New Business: Town and Country estimated \$4750 to repair and re-stripe the basketball court at Alyea. We were told it didn't need resealing.

Five-Year Park Plan: Don made a motion to have the public hearing for the 5-year plan on Thursday, September 14th. Jenny seconded, and the motion passed. Splash pad is our first choice. Second choice is either a dog park or extending the trail. Cohen and basketball courts. will be next year's focus.

Ten shrubs will be planted this fall along the trail. Don made a NTE of \$250 to pay for the shrubs. Jenny seconded, and the motion passed.

D.R.Horton will fund 50 trees which we will need to map where to plant. Don made a motion to accept Frank's list of trees; Dorothy seconded, and it passed.

As there was no further business to come before the board, Dorothy made a motion to adjourn; Cindy seconded, and the motion passed. The meeting closed at 9:43 pm.
